**UPON** the Respondent having applied on 6 April 2017 under CPR 5.4C(2) for permission to obtain from the records of the Court copies of documents filed by the original parties to the litigation (the "Application");

**UPON** Master McCloud making certain interim orders on 6 and 12 April and 10 August 2017 in relation to the Application;

**UPON** Master McCloud having handed down judgment and making a final Order on 5 December 2017 permitting the Respondent to copy certain documents (the "Final Order");

**UPON** the Appellant issuing a Notice of Appeal on 21 December 2017 (the "Appeal");

**UPON** the appeal being transferred from the High Court to the Court of Appeal by Order of Martin Spencer J dated 5 March 2018;

**AND UPON HEARING** Leading Counsel for the Appellant and Leading Counsel for the Respondent;

#### IT IS ORDERED THAT

- 1. The Appeal is allowed.
- 2. The Final Order of Master McCloud is set aside.



- 3. The Appellant is permitted to retrieve from the Court Office of the Queen's Bench Division all documents and bundles currently located there save those on the court file, including in particular: (a) all the documents referred to at paragraph 1 of the Order of Master McCloud dated 6 April 2017; and (b) the hard drive containing a copy of Bundle D from the original trial before Picken J, delivered to the Court pursuant to the Order of Master McCloud made on 12 April 2017.
- 4. The Court shall (so far as they are on the court file and the prescribed copying fee is paid) provide the Respondent with copies of the following documents from the court record pursuant to CPR 5.4C(1):
  - (a) Statements of case (including requests for further information and answers) save for those set out in Appendix 1; and
  - (b) The Claimant's Second Further Particulars of Paragraph 5 of the Amended Particulars of Claim dated 6<sup>th</sup> April 2016.
- 5. The Appellant's application for permission to appeal is refused.
- 6. Paragraphs 7 8 of this Order are stayed pending the determination by the Supreme Court of the Appellant's application for permission to appeal and, if permission to appeal is granted, pending the determination of that appeal.
- 7. The Appellant shall, on payment by the Respondent to the Appellant of the Appellant's reasonable copying costs, provide the Respondent with one copy of each of those documents listed in Appendix 2 to this Order.
- 8. The Application be listed for a further hearing before Picken J (or, if that is not possible, a different High Court judge) to determine:
  - (a) whether any other document sought by the Respondent and not listed in the Schedule, falls within the scope of paragraph 112(2)(ii) and/or (iv) of the Judgment; and
  - (b) in relation to any such document, whether the Court should, in the exercise of its inherent jurisdiction, require the Appellant to provide a copy of it to the Respondent, having regard (among other matters) to the factors at paragraphs 127 and 129 of the Judgment.
- 9. There shall be no order as to costs below and on appeal.
