These are some of the questions we are often asked about when clients are making a claim following a injury. For anything else, or to discuss a potential claim, please contact us on the number below.

#### How do I make a claim?

Contact us on **020 7650 1198** as soon as possible to find out whether you can make a claim.

You will be asked a series of questions by a member of our specialist team. We will then assess whether you have a claim and this initial consultation is free of charge.

Most of our cases are taken on a 'no win, no fee' basis, otherwise known as a conditional fee agreement. Alongside this, you will need after the event insurance which we will arrange for you.

Before agreeing to take a claim forward we will explain fully how your claim is funded.

Usually if your claim is successful, the other side, (the defendant) pays your legal costs, with a capped percentage coming from your compensation award.

Generally, if your claim is unsuccessful, you will not need to pay any legal costs.

#### How long do I have to make a claim?

It is usually three years from the time when you were injured or the date of diagnosis of a disease.

Some clients are regarded as Protected Parties, who do not have mental capacity to act on their own behalf in the litigation. Special time limits apply to children and Protected Parties and we have specialist lawyers who have vast experience representing such clients.

#### How long will it take?

Every case is different, but we aim to bring a case to its earliest conclusion, whilst insuring all of the evidence needed to prove the claim is obtained. We also attempt to ensure that any expenses and losses you face are covered by interim payments where possible. These payments can cover the costs of specialist care and therapies during rehabilitation, loss of earnings etc which is why getting legal help as soon as possible is key. Cases can take years to fully conclude, but throughout your claim our aim is to keep you updated and where possible, facilitate financial support via interim payments.

#### Will I have to go to court?

Most cases are settled before attending court for a trial becomes necessary. The expertise of the team, from many years of bringing claims on behalf of those who have suffered injury, means that we will secure the evidence and the expert opinion to fight your corner. We aim to ensure that you receive justice and compensation for your injuries as soon as possible.



#### Natasha's Story

Leigh Day represents Nadim and Tanya Ednan-Laperouse, the parents of 15-year old Natasha Ednan-Laperouse, who died from anaphylaxis due to inadequate allergen labelling protocols.

Natasha's Inquest highlighted the deficiencies of the Regulations. The Coroner, Dr Sean Cummings, wrote to Michael Gove, Secretary of State for the Environment, Food and Rural Affairs, requesting a review of the Regulations. The Regulations required an urgent amendment to compel food businesses to list all ingredients, including allergen information. Leigh Day supported the Ednan-Laperouse family in calling for 'Natasha's Law' to be implemented.

In January 2019, after meeting with Natasha's family and members of the Leigh Day food safety team, Environment Secretary Michael Gove announced the launch of a consultation into food labelling laws. This focused on overhauling the labelling of pre-prepared foods, which are made, packaged and sold in-store.

Nadim and Tanya Ednan-Laperouse, assisted by the Leigh Day food safety team, secured legislative changes to allergen food labelling law. Natasha's law came into effect on 01st October 2021 in England, Wales and Northern Ireland, will require food businesses to provide full ingredient lists and allergen labelling on foods packaged for sale on the premises.
